### **Meeting summary:**

#### **Call to order**

Shawn Wilcox called the meeting to order at 9:05 AM on Saturday 13<sup>th</sup>, 2025 in the Maple Room at the Fluvanna County Volunteer Rescue Squad in Palmyra.

#### **Attendance**

A total of 13 club members were in attendance including the following board members: Dave Beazley, Mac Derry, Dave Eames, Scott Lounsbury, Shawn Wilcox. (See attached attendance list).

#### **Review of the November 13<sup>th</sup> BoD meeting minutes**

Dave Eames provided highlights of the minutes which are available on the club website.

#### **Financial Report – Dave Beazley**

Dave Beazley stated that we currently have 34 members. We now have a PayPal account set up which can be used to pay annual dues. There is a transaction charge for this service so there will probably be an additional ~\$2 requested to be paid by members who renew by PayPal. Dave Beazley will still accept payment by check. He then provided the following financial report:

We started out 2025 with \$2,199.94 so we had a net income of \$2,567.22

We currently have 5 paid members for 2026 totaling \$295.26 (PayPal charges 2.6% for payments so Dave suggested in future we adjust PP dues to cover expenses)

- **Field upgrade** We discussed an opportunity to improve our field by replacing the GeoTex runway with asphalt and agreed that until we had managed to get a 10-year MoU in place with the Fluvanna County Board of Supervisors it was premature to provide any details.

We also acknowledged the work that Shawn and Scott had done to upgrade the entrance gate and to provide electricity to the shelter via a generator located in the storage shed.

- **AMA field improvement grant** Shawn will apply for a grant which, if approved, would provide up to a 25% funding reimbursement up to a limit of \$3,000.
- **Annual Dues Increase** It was agreed by vote of all members that we should increase the annual dues to \$100 per year. This will start on January, 31<sup>st</sup> 2026. Until that time, members could renew their 2026 membership at the \$60 rate (plus \$2 if using PayPal).

### **Elections**

We received the following four nominations for the four open positions and they were all approved by voice acclamation.

- Patrick Flathers
- Jacob Shaner

Shawn will schedule the first BoD meeting in January 2026.
